SUBJECT: Well Management fee increases

The Minnesota Department of Health is responsible for regulating the construction, maintenance, and sealing of wells and borings to ensure these activities are conducted in a manner that protects public health, groundwater, and the environment.

The Well Management Section is issuing this Information Notice to inform external parties to the recent fee changes in [Minnesota Statutes, 103I](#) authorized by the 2025 Minnesota Legislature. **The new fee amounts are effective July 1, 2025, and are listed below.**

<b>Definition:</b> An environmental well site includes all of the environmental wells on a single property. A single property is considered on tax parcel or multiple contiguous parcels with the same owner.

Environmental Well Site Maintenance permit 11-20 environmental wells per site	\$325.00
Environmental Well Site Maintenance permit 21 and over environmental wells per site	\$425.00
