## Cov lus taw qhia

Minnesota Department of Health (MDH) xa cov hnab ntawv ntawm cov ntaub ntawv luam tawm raws kev xa ntawv mus rau cov tsev neeg hauv Minnesota uas muaj cov me nyuam uas nyuam qhuav tau txais kev txheeb qhia tias yog neeg lag ntseg los sis tsis hnov lus zoo. Cov ntaub ntawv no muab cov peev txheej feem ntau hauv daim foos ntawv es les thos niv thiab muab cov peev txheej ua Lus Hmoob, thaum muaj. Cov peev txheej uas tsuas muaj nyob hauv daim foos ntawv luam tawm tsis suav nrog hauv daim ntawv teev npe no, thiab hloov rau qhov ntawd, peb txuas mus rau lub koom haum lub vev xaib ncaj qha.

Cov ntaub ntawv no yog npaj rau cov niam txiv uas xav kom muaj qhov kwv yees hauv es lev thos niv ntawm cov ntaub ntawv uas tau luam tawm. Rau cov neeg hauv tsev neeg uas nthuav dav ntxiv, cov kws qhia ntawv, cov kws muab kev pab cuam saib xyuas kev noj qab haus huv thiab cov neeg tawm tswv yim hauv tsev neeg, hom es lev thos niv no yog tau tsim los qhia kev sib tham los sis pab kom cov tsev neeg nkag siab cov ntaub ntawv uas luam tawm los.

## Kev nthuav tawm cov ntaub ntawv

## Sib huab hwm txog kev txheeb qhia txog tus kheej

Peb huab hwm txog lo lus cov neeg siv los txheeb xyuas lawv tus kheej. “Kev cuam tshuam thaum ntxov” (“early intervention”) yog kev txhawb nqa thiab kev pab cuam rau cov me nyuam yaus uas yuav muaj los sis muaj kev pheej hmoo rau kev loj hlob qeeb thiab lawv tsev neeg.
