

MDH Vaccine Programs and MIIC

Sites that participate in the Minnesota Vaccines for Children (MnVFC) program and the Uninsured and Underinsured Adult Vaccine (UUAV) program can use the Minnesota Immunization Information Connection (MIIC) to order and manage vaccine.

Vaccine ordering

You can create, view, and track MDH vaccine orders directly in MIIC. If you order in MIIC, you will receive vaccine order and shipping confirmation emails.

Reporting vaccine returns and wastage

You can use the MDH Nonviable Vaccine Form in MIIC to report MDH vaccine returns and wastage. Once MDH approves your form, you will receive a confirmation email. If you report vaccine returns, you will also receive an email from UPS with shipping labels you can use to return your vaccine. You can view pending and past form submissions in MIIC at any time.

Reporting dose-level eligibility

You can report MnVFC eligibility status for children and insurance status for adults at the vaccine dose-level in MIIC. MDH calls this “dose-level eligibility (DLE).” Submitting DLE to MIIC improves the quality of your vaccine data and allows you to use MIIC reports to monitor vaccine accountability. This is required for sites that practice the replacement method of vaccine management but strongly encouraged for all sites.

If you submit DLE to MIIC, you can use MIIC's MnVFC Report to produce part of the MnVFC Program Annual Report of Immunized Pediatric Patients.

Doses administered by eligibility report

If you submit DLE to MIIC, you can use MIIC's Doses Administered by Eligibility Report to assess the number of MnVFC vaccine doses your site has given to pediatric patients. This information can help inform your next MnVFC vaccine order. It can also help you monitor your DLE data quality. For example, vaccines with an eligibility value of “unknown” may indicate an issue with how your site is sending DLE information to MIIC.
